- Ensure personnel are fully trained and competent in the completion of the cleaning task required.
- Ensure personnel understand all chemical handling protocols.
- Utilisation of appropriate technology, including automated chemical dispensing systems, spray and/or squirt bottles.

# Training

Milestone Chemicals Australia are willing and capable of providing on-site in-service training in the introduction, development and implementation of the *MyChoice sustainable cleaning program*.

- Contain NO substances causing skin/respiratory irritation (i.e. strong fragrances)
- Readily Biodegradable
- Minimal Packaging, containing recyclable materials, with 'drum return' policy.
